- 1. My participation on the Tour/s will constitute my full consent to being filmed and photographed thereon and to any and all uses by Vendor of such film and photographs which may contain my likeness and/or voice and/or any other indicia of my persona, including the license thereof to the series "Supernatural". I hereby release the Vendor, the series "Supernatural," and its producers from all liability related thereto.
- I understand the Tour/s in which I am participating may involve hazardous conditions and/or transportation. Certain heavy equipment and/or fireworks, explosives and/or cables may be utilized on the Tour/s. On behalf of myself, my heirs, assigns, executors, administrators and any others who may take by or through me, I agree to release, indemnify and forever discharge the Vendor, the series "Supernatural," its producers and their respective parents, divisions, subsidiaries, affiliates, successors and assigns from any and all claims or liabilities (including, without limitation attorneys' fees) whatsoever for injuries or damages of any kind sustained in connection with my participation on the Tour/s, including without limitation, any injury, damage, death, loss, or accident to person or property. In addition, I acknowledge that any personnel involved in the Tour/s and also associated with the series "Supernatural" has been employed by Vendor exclusively for purposes of the Tour/s and are not performing services on behalf of the series or as an employee thereof.
- 3. During participation on the Tour/s, I acknowledge that I may observe or otherwise be subjected to Confidential Information (as defined herein below), and I agree not to, nor will I permit anyone to, publish, sell, exhibit or otherwise exploit the Confidential Information in any physical and/or digital media or otherwise, including without limitation posting any such Confidential Information on the internet. "Confidential Information" shall mean information that I discover through visual or physical inspection or otherwise during my participation on the Tour/s, which information relates to the series "Supernatural" or any of its related works (the "Property"), including, without limitation, any information concerning the scripts, characters, themes, plots, story, story elements, designs, artwork, sets or visual concepts related to the Property, and any information related to the development or production of the Property.
- 4. On the tour of the set of "Supernatural," PHOTOGRAPHY BY ANY DEVICE WILL BE STRICTLY PROHIBITED. However, I understand the Vendor has secured a limited exception to this rule so I can take a photograph with the Impala featured on "Supernatural." Such photograph will be and is solely for my personal use and enjoyment, and constitutes Confidential Information hereunder. I agree not to, nor will I permit anyone to, publish, sell, exhibit or otherwise exploit this photograph (or any other, if any) at any time in any physical and/or digital media whatsoever, including without limitation posting any such photograph/s on the internet. For the tour of the locations used in filming "Supernatural," photography will be permitted but the photographs are subject to the same limitations above regarding personal use, enjoyment and no digital distribution or sale. In addition, my participation on the Tour/s shall not delay the movement of the tour nor prevent any other visitor from enjoying the Tour/s on account of my permitted photography hereunder, or otherwise. I understand that the Vendor, the tour guide and/or the convention manager may at any time in their respective and absolute discretion curtail or prohibit any photography and I agree to abide by their decision.
- 5. I understand and agree that the Vendor, the series "Supernatural," its producers and any of their assigns shall be entitled to pursue any remedy at law or in equity for any breach or violation by me in connection with this agreement, and I agree to defend, hold harmless and indemnify same against any claims in connection therewith.
- 6. I agree to abide by any other rule or regulation made known to me by Vendor or its agents, and to cooperate fully with any direction or instruction given throughout my Tour/s. I understand that the Tour/s and/or my participation therein, may be revoked at any time and for any reason. This Agreement constitutes the complete understanding between the Parties regarding my participation on the Tour/s and may not be modified except in writing with the signatures of both Parties.
